

Privacy Policy

Please take the time to read this statement. In it, we explain to you what data we collect from you, for what purposes we process it, to whom we may pass on this data and what legal options you are entitled to.

All data processing is carried out on the basis of the relevant legal regulations and only for purposes within the scope of our corporate purpose.

On the one hand, we process data that you provide to us yourself, and on the other hand, data that we receive through your use of our website.

Processing of data that you provide to us

1

MyVdFS

When you log into our internal area for beneficiaries ("MyVdFS"), we collect all the data that you provide to us and enter into our database. You can view the works/contributions recorded in our database in MyVdFS and export your list of works. In addition, actors can enter the information on role names and shooting days. You can change your master data as well as your password and e-mail address.

If you want to reset your password or provide us with an e-mail address for the first time, we will process your VdFS ID and send you an activation link to the e-mail address provided.

We store the access data for MyVdFS until the end of your access authorization. We store your master data and data on works for as long as is necessary for the fulfilment of our statutory tasks (including royalty accounting). We store those data that we are also legally obliged to store, e.g. according to accounting regulations, until the expiry of the respective statutory period.

Evaluation of newsletter usage

If you have registered for our newsletter, we will collect the data you provide (title, title, title, name, e-mail address). The provision of title, first and last name as well as e-mail address is mandatory. If you do not provide us with this data, you will not be able to receive our mailings.

The VdFS will use the data you provide when subscribing to this newsletter to stay in touch with you and to send you news about the Austrian film scene and the VdFS. We evaluate your use of the newsletter individually in order to be able to better tailor our mailings to your interests and needs.

To do this, we store your reactions (e.g. opening the newsletter, your clicks on image and text links) and the e-mail program used.

You can object to the evaluation of the newsletter use at any time via a link in each mailing and by sending a message to office@vdfs.at. In the event of an objection, we will revoke your use of the newsletter

do not evaluate on a personal basis. We store the data you provide for the duration of the newsletter subscription.

Processing of data we collect through your use

No personal data is required to use our website. However, our web server still collects the data that your internet browser tells us (including the name of the page or file accessed, date and time, internet browser used, the page from which you came to us (referrer), screen resolution and operating system). We process this data so that we can find errors and improve our service. This data will be stored for a maximum of 1 year. It is not possible to draw any conclusions about your person from this data.

We collect data about your use of our online presences via the provider listed below in the section "Cookies and visitor statistics" in order to be able to adapt them to your interests in the best possible way.

When do we share data?

Your personal data will be used exclusively by us and will not be passed on to third parties without your consent, a legal obligation or a judicial or official decision. If we use third parties ("processors") to carry out orders, we will ensure that they use your data exclusively within the framework of the agreement concluded with them, our orders and in compliance with data protection regulations.

Cookies and visitor statistics

This website uses **Google Analytics**, a web analysis service provided by Google Inc. ("Google"). Google Analytics uses so-called "cookies", which are text files that are stored on your computer and enable an analysis of your use of the website.

The following cookies are stored on your computer and read: _gid (storage period one day), _ga (storage period two years), _gat (storage period one minute)

The information generated by the cookie about your use of this website (including your IP address) is usually transmitted to a Google server in the USA and stored there. Google will use this information on our behalf to evaluate your use of this website, to compile reports on website activity for Google Users.

and to provide us with other services related to the use of the website and the use of the Internet. We use the reports generated by Google exclusively to optimize our website and for market research. The IP address transmitted by your browser as part of Google Analytics will not be merged with other data held by Google. Google may also transfer this information to third parties if this is required by law or if third parties process this data on Google's behalf. Google will never associate your IP address with any other data held by Google. You can prevent the storage of cookies by setting your browser software accordingly; however, we would like to point out that in this case you may not be able to use all the functions of this website to their full extent. You have the option of completely preventing the collection of the data generated by the cookie and related to your use of the website (including your IP address) by Google and the processing of this data by Google – for this purpose, you must install a browser add-on at

We have added the code "gat._anonymizeIp();" to Google Analytics so that your IP address is processed in an abbreviated form (IP anonymization). Your rights

You have the right to request information from us about all processed data, the correction or deletion of this data or the restriction of the processing of the data. If you withdraw your consent, this does not affect the lawfulness of the data processing carried out up to this point. You also have the right to receive personal data concerning you in a structured, commonly used and machine-readable format.
